INDEPENDENT AUDITOR'S REPORT

To the Members of PATRATU ENERGY LIMITED RANCHI

Report on the Financial Statements

We have audited the accompanying financial statements of **PATRATU ENERGY LIMITED** ("the Company") which comprises the Balance Sheet as at 31st March, 2018, the Statement of Profit & Loss for the year then ended and a summary of significant accounting policies and other explanatory information.

Management's Responsibility for the Financial Statements

The Company's Board of Directors is responsible for the matters stated in Section 134(5) of the Companies Act, 2013 ("the Act") with respect to the preparation and presentation of these financial statements that give a true and fair view of the financial position and financial performance of the Company in accordance with the accounting principles generally accepted in India, including the Accounting Standards specified under Section 133 of the Act, read with Rule 7 of the Companies (Accounts) Rules, 2014. This responsibility also includes maintenance of adequate accounting records in accordance with the provisions of the Act for safeguarding the assets of the Company and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the financial statements that give a true and fair view and are free from material misstatement, whether due to fraud or error.

Auditor's Responsibility

Our responsibility is to express an opinion on these financial statements based on our audit.

We have taken into account the provisions of the Act, the accounting and auditing standards and matters which are required to be included in the audit report under the provisions of the Act and the Rules made thereunder.

We conducted our audit in accordance with the Standards on Auditing specified under Section 143(10) of the Act. Those Standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and the disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal financial control relevant to the Company's preparation of the financial statements that give a true and fair view in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on whether the Company has in place an adequate internal financial controls system over financial reporting and the operating effectiveness of such controls. An audit also includes evaluating the appropriateness of the accounting policies used and the reasonableness of the accounting estimates made by the Company's Directors, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion on the financial statements.

Opinion

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid financial statements give the information required by the Act in the manner so required and give a true and fair view in conformity with the accounting principles generally accepted in India:

- a. in the case of the Balance Sheet, of the state of affairs of the Company as at March 31, 2018; and
- b. in the case of the Statement of Profit and Loss, of the loss for the year ended on that date.
- c. in the case of the Cash Flow Statement, of the cash flows of the company for the year ended on that date.

Emphasis of Matters

- 1. Tax Deducted at Source amounting to Rs.10,000/- was not paid by the company till the date of audit.
- 2. Current tax pertaining to earlier financial year amounting to Rs.30,71,402/- was not paid till the date of audit.
- 3. The fundamental assumption of going concern that the entity will continue its operation for a reasonable period of time has become doubtful. The company is not engaged in any kind of revenue generating operation during the year and the financial health of the entity is adverse as it is noticeable by its negative balance of reserve and surplus amounting to Rs. 7,52,24,014/-

Our opinion is not qualified in respect of the above matters. Report on Other Legal and Regulatory Requirements

1. As required by the Companies (Auditor's Report) Order, 2015 ("the Order") issued by the Central Government of India in terms of sub-section (11) of section 143 of the Act, we give in the **Annexure A** a statement on the matters specified in the paragraph 3 and 4 of the Order, to the extent applicable.

- 2. As required by section 143(3) of the Act, we report that:
 - a. we have sought and obtained all the information and explanations which to the best of our knowledge and belief were necessary for the purpose of our audit;
 - b. in our opinion, proper books of account as required by law have been kept by the Company so far as it appears from our examination of those books.
 - c. the Balance Sheet and the Statement of Profit and Loss dealt with by this Report are in agreement with the books of account;
 - d. in our opinion, the aforesaid financial statements comply with the Accounting Standards specified under Section 133 of the Act, read with Rule 7 of the Companies (Accounts) Rules, 2014.
 - e. as per the notification no. G.S.R. 463(E) dated 5th June, 2015, sub section (2) of section 164 of the Companies Act, 2013 is not applicable to Government Companies.
 - f. with respect to adequacy of the internal financial controls over financial reporting of the Company and the operating effectiveness of such controls, refer to our separate report in "Annexure B"; and
 - g. with respect to the other matters to be included in the Auditor's Report in accordance with Rule 11 of the Companies (Audit and Auditors) Rules, 2014, in our opinion and to the best of our information and according to the explanations given to us, we report that:
 - i) The corporation does not have any pending litigations which would impact its financial position.
 - ii) The corporation did not have any long-term contracts including derivative contracts for which there were any material foreseeable losses.
 - iii) There were no amounts which were required to be transferred to the Investor Education and Protection Fund by the corporation.

On the basis of such checks as we considered appropriate and according to the information and explanations given to us during the course of our audit, we report that:

- (i) The company has not maintained proper records showing full particulars of capital work in progress shown under the head Fixed Assets and also management has not maintained fixed assets register.
 - (b) As explained to us, the management has physically verified fixed assets at the beginning of the financial year and no discrepancies were noticed on such verification.
 - (c) As explained to us, the company has not purchased any fixed asset during the year of audit, hence this clause is not applicable.
- (ii) The Company has no inventory during the year. Accordingly, the clause (ii) of the Order is not applicable to the Company.
- (iii) The Company has not granted any loans, secured or unsecured to Companies, firms, limited liability partnerships or other parties covered in the register maintained under section 189 of the Companies Act,2013. Therefore this paragraph of the Order is not applicable to the company.
- (iv) In our opinion and according to the information and explanations given to us, there are no loans, investments, guarantees and securities granted in respect of which provisions of section 185 and section 186 of the Companies Act 2013 are applicable.

We have audited the internal financial controls over financial reporting of **PATRATU ENERGY LIMITED** as of March 31, 2018, in conjunction with our audit of the standalone financial statements of the Company for the year ended on that date.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion on the Company's internal financial controls system over financial reporting.

Meaning of Internal Financial controls Over Financial Reporting

A company's internal financial control over financial reporting includes those policies and procedures that (1) pertain to the maintenance of records that, in reasonable detail, accurately and fairly reflect the transactions and depositions of the assets of the company; (2) provide reasonable assurance that transactions are recorded as necessary to permit, preparation of financial statements in accordance with generally accepted accounting principles, and that receipts and expenditures of the company are being made only in accordance with authorisations of management and directors of the company; and (3) provide reasonable assurance regarding prevention or timely detection of unauthorized acquisition, use, or disposition of the company's assets that could have a material effect on the financial statements.

Inherent Limitations of Internal Financial Controls Over Financial Reporting

Because of the inherent limitations of internal financial controls over financial reporting, including the possibility of collusion or improper management override of controls, material misstatements due to error or fraud may occur and not be detected. Also, projections of any evaluation of the internal financial control over financial reporting to future periods are subject to the risk that the internal financial control over financial reporting may become inadequate because of changes in conditions, or that the degree of compliance with the policies or procedures may deteriorate.

Qualified Opinion

According to the information and explanation given to us and based on our audit, the following material weaknesses have been identified in the operating effectiveness of the Company's internal financial controls over financial reporting as at March 31, 2018.

- a) The Company's internal financial controls over Long Term Borrowings were not operating effectively since the Company does not have any source of income which cast a significant doubt about the company's ability to repay the borrowings.
- b) In our opinion, the fundamental assumption of going concern that the entity will continue its operation for a reasonable period of time has become doubtful. The company is not engaged in any kind of revenue generating operation during the year and the financial health of the entity is adverse as noticeable by the following indicator:
 - The company has a negative balance of reserve and surplus.

In our opinion, the Company has, in all material respects, maintained adequate internal financial controls over financial reporting as of March 31, 2018 based on "the internal control over financial reporting criteria established by the company considering the essential components of internal control stated in the Guidance Note on Audit of Internal Financial Controls Over Financial Reporting issued by "the Institute of Chartered Accountants of India" and except for the possible effects of the material weaknesses described above on the achievement of the objectives of the control criteria, The Company's internal financial controls over financial reporting were operating effectively as at March 31, 2018. We have considered the material weaknesses identified and reported above in determining the nature, timing and extent of audit test applied in our audit of the March 31, 2018 financial statement of the Company, and these material weaknesses does not affect our opinion on the standalone financial statements of the Company.
